What is DOCX?



DOCX is:

- A word processing file format based on open standards, including Extensible Markup Language (XML)
- Supported by many popular word processing applications, such as Microsoft Word, Google Docs, and LibreOffice



Why DOCX?

DOCX benefits

- Secure: automatic metadata detection and scrubbing (e.g., author, company, last modified by, comments, bookmarks)
- Generates a feedback document pre-submission where warnings and errors are pinpointed in a copy of the uploaded document in real time
- Abstract word count, improper multiple claim dependency, independent and dependent claim count, duplicate or missing claim number detection, specification paragraph numbering detection
- A copy of the DOCX documents are available for download before and after completing a submission to the USPTO



DOCX benefits

- Detects and splits specification, claims, abstract and drawings found in a single file (i.e., multi-section document) in Patent Center
- Automated document code assignments saves initial processing time
- Requirement to convert DOCX into PDF for filing is eliminated
- DOCX documents can be created in a variety of programs, including Microsoft Word 2007 or higher, Google Docs, Office Online, LibreOffice, and Pages for Mac.
- Additional fonts are now acceptable with DOCX
 - Filing in DOCX eliminates the non-embedded font error, the most common error in uploading a PDF
 - A list of currently acceptable fonts are listed on the <u>USPTO DOCX</u> website, and we are adding more all the time

Why should you switch?

- DOCX is a safe and stable basis for authoring and processing intellectual property documents
- Reduces time responding to non-compliant notices
- Enhances quality of examination by providing contentbased validations pre-submission
- What you submit is what we review
- Starting January 1, 2022, a surcharge up to \$400 will apply when filing a new nonprovisional utility application* in PDF format

DOCX filing is available in both Patent Center and EFS-Web with some key differences



Filers can file nonprovisional utility, provisional, and national stage application types; follow-ons on the same day	Filers can only file nonprovisional utility applications			
File multi-section (specification, claims, abstract, drawings) in a single document for Patent Center to automatically detect and assign document codes	Filers must manually split documents into separate single-section documents prior to upload			
New technology will allow for future enhancements such as submission of amendments and responses	Only specification, claims, abstract may be uploaded in DOCX




Abstract

This is an example of an abstract of the invention. In this abstract example we will exceed 150 words. Since MPEP section 608.01(b) recommends that the number of words in the abstract be within the range of 50-100 words, this is a useful detection provided by our USPTO DOCX system. After detection of the abstract of the invention, the number of words are validated. Upon uploading the abstract, the user is immediately notified if they have exceeded this amount and a feedback document is provided to the user pre-submission. Upon opening the feedback document, a message indicated that the number of words in the abstract has been exceeded will be shown. The user may desire to delete, modify and upload the abstract again. The user will be able to easily identify where the number of words are exceeded since the system will indicate the exact location of the extra words.





Patent Center-intuitive application viewer


